US government will ban Americans from air travel effective May 2025 unless they have federalized 'Real ID' driver's license – Leo Hohmann – June 3, 2024

Excerpt: The long-awaited deadline is finally approaching on May 7 and it will disqualify many from boarding commercial airplanes, whether domestic or international flights.

The globalists are moving quickly to crush our freedom of movement, and the US government is all in.

The freedom-crushing policies come under many false pretenses. They come under the guise of national security, protecting the planet from so-called climate change, and protecting us from public-health emergencies.

I reported yesterday on the U.N. World Health Organization adopting a set of freedom-crushing amendments to the existing International Health Regulations. This will lead to forced testing, quarantining and injections, among other harassments, of international travelers, all under the guise of looking out for our health. The IHR amendments also give WHO member states the authority to use “surveillance” to “address” issues of “disinformation” and “misinformation.” They don’t spell out or define the meaning of “address” but we should assume this means governments will have greater censorship powers to clamp down on anyone who releases information contrary to the globalist establishment narrative about the need for mass-testing, mass-injection campaigns or any other public-health issues.

Today, I bring to your attention another government policy that’s about to take effect that will crush domestic air travel under the guise of *national security*.

Investors and speculators were rapidly losing confidence in the UK government, mostly due to the ridiculous "Exchange Rate Mechanism" (ERM) which essentially pegged most European currencies to the German Deutschemark.

Rational investors viewed the ERM as an almost comical impossibility.

Germany's economy was light years ahead of everyone else. Germany had vastly higher productivity, far greater savings, low inflation, high growth, and much more responsible monetary policy.

So, to even pretend that a country like Italy or even Britain could fix its exchange rate to the Deutschemark, i.e. to essentially mirror Germany's economic performance- was a total joke.

... This is an important story to understand, because it's likely that something similar may happen to the Federal Reserve and US dollar over the next several years.

The Federal Reserve is already insolvent.

According to its most recent annual financial statements, the Fed has just \$51 billion in equity, versus a whopping \$948 billion in mark-to-market losses. This means the Fed is insolvent by roughly \$900 billion.

This is a big problem. Remember that the Fed is still a bank, i.e. it has financial obligations, liabilities, and depositors that it needs to pay.

For example, commercial banks like JP Morgan and Bank of America have deposited a total of \$3.4 trillion of their customers' money, i.e. YOUR money, with the Fed. And the Treasury Department holds another \$700 billion deposit at the Fed.

The Fed owes money to foreign governments. They owe trillions of dollars from repurchase agreements to banks and businesses across the global financial system.

The first group of French military instructors are on their way to Ukraine, senior Ukrainian MP Aleksey Goncharenko said on Friday.

"My sources informed me that the first group of French instructors is already on its way to Ukraine," Goncharenko, a member of the Ukrainian parliament and delegate to the Parliamentary Assembly of the Council of Europe, wrote on X (formerly Twitter) on Friday evening.

The idea of deploying NATO boots on the ground remains a contentious issue within the US-led bloc, whose members maintain that they are not parties to the conflict between Russia and Ukraine. Moscow, however, has said that it views Ukraine's Western backers as direct participants, stressing that Western-supplied weapons are being used to strike targets on Russian soil.

We Will Not Send One Italian Soldier to Fight': Matteo Salvini Slams NATO's War Agenda – RAIR Foundation – USA – June 3, 2024

Salvini criticized NATO Secretary-General Jens Stoltenberg, saying, “Mr. Stoltenberg should either take it back, apologize, or resign. More weapons, more missiles, more bombs. Italy is not at war with anyone. Let Stoltenberg and Macron [Emmanuel] go to war! Let bomb-makers go to war!”

Cyberattack could trigger Article 5 – NATO – RT – June 1, 2024

Excerpt: A major IT strike by a state actor could result in a military response from the US-led bloc, Admiral Rob Bauer has said.

A large-scale state-sponsored attack on a NATO member could trigger the bloc's Article 5 collective defense clause and result in a military response, the chair of NATO's military committee, Admiral Rob Bauer, said on Saturday.

Bauer made the remarks at the Shangri-La Dialogue, an annual security conference organized by the International Institute for Strategic Studies (IISS) in Singapore. Speaking about cybersecurity threats, the admiral reaffirmed the bloc's readiness to respond militarily – even to a viral attack.

“In NATO, we have agreed amongst all allies that, in principle, a cyberattack can be the start of an Article 5 procedure. So it's not only a physical attack, but also a cyberattack can be the basis of an Article 5 debate and of course result in the follow-on procedures,” Bauer stated.

A collective response to a cyberattack, however, could be subject to various uncertainties, he admitted. Unlike in the case of a *“physical”* attack, it could be hard to determine who exactly was behind it or whether a state-level actor was involved.

Maheer: If Trump Goes To Jail There Will Be A Racial Civil War – Modernity News - Steve Watson - 2nd June 2024

Excerpt: HBO ‘Real Time’ host Bill Maheer has predicted that if Donald Trump is sentenced to any prison time, there will be a civil war that will quickly evolve into a race war because of MAGA supporters.

“Here’s the key question: Is he going to go to jail? Would this judge dare do that?” Maheer said, adding “And should he? I heard some people say if his name wasn’t Donald Trump he would definitely get jail time.”

“MAGA nation will go nuts. I don’t know if that’s a reason to or not to do something, but they will,” Maheer continued during the discussion with former Obama chief strategist David Axelrod.

Maheer went on to suggest that “because the judge’s name was Juan,” putting Trump in jail would lead to racial political violence.

“Everything becomes racial in this country. That’s partly because of our horrible, despicable racial past, partly because some of that racism lives on in the present and some of it because the far left makes everything racial. But that’s what it’s going to be.” Maheer further posited.

“A civil war in this country, I’m sorry to say, becomes a race war. That’s the sad truth about this country,” the host continued, adding “And if they put him in jail, I mean, the first thing his supporters are going to say is, ‘Oh, that’s what it is.’ A Black district attorney. You know, all these people who are the district attorneys, they’re black. The judge was not White. This is what it is.”

Gallant vows war won’t end until Hamas is destroyed; IDF advances further in Rafah – The Times of Israel - By EMANUEL FABIAN and TOI STAFF2 June 2024, 8:16 pm

Excerpt: Defense minister says Israel ‘advancing an alternative’ to terror group’s rule; troops find rocket launchers, arms near Egypt border; fighter jets hit over 30 targets across Gaza.

Defense Minister Yoav Gallant said Sunday that Israel was working on finding a replacement for Hamas’s rule in the Gaza Strip, vowing that the war will not end until the terror group is dismantled of both its military and governmental capabilities.

“In any process of ending the war, we will not accept Hamas rule. We are advancing an alternative government to Hamas, within the framework of which we will isolate areas, remove the Hamas members and bring in other forces that will enable a different government,” Gallant said following an assessment at the Southern Command in Beersheba.

Hundreds of Lawmakers Worldwide Warn The WHO’s ‘Pandemic Treaty’ Would Usher In ‘Tyranny And Oppression’ – Harbinger’s Daily – June 2, 2024

Excerpt: Hundreds of officials from dozens of countries have put the leader of the World Health Organization on notice that if he persists in violating WHO rules to adopt a controversial global pandemic agreement or amend the International Health Regulations (IHR), it will render those provisions “null and void.”

Delegates remain huddled in Geneva as the clock ticks away the remaining moments of the 77th annual World Health Assembly, where some had hoped to finalize the pandemic agreement and pass amendments to the IHR, which would allow a global governance institution to guide some of the most sensitive areas of sovereign nations’ health care policy.

As of this writing, 216 elected officials from 34 nations have [signed a letter](#) instructing WHO Director-General Tedros Ghebreyesus that any effort to adopt the proposed [WHO Pandemic](#)

Agreement or IHR amendments this week would “violate the principles of good governance,” break organizational rules, and usher in an era of “tyranny and oppression.”

The most recent draft of the pandemic agreement would compel Americans to turn over 20% of their supplies to WHO for “equity”-based global redistribution, follow WHO policies on “routine immunization” and “social measures” such as lockdowns, and accept a “One Health” policy that equates human life with plants and other life forms. The uncertainty of multiple provisions makes the treaty “a blank check” to “unaccountable committees,” say the elected officials, including eight Republican Members of Congress.

But they argue the provisions of any agreement WHA authorizes this week will have no impact, because WHO rules would invalidate the document.
